An email was sent to the year round water users asking for them to submit the meter identification numbers and current water meter readings. The response has been excellent.

The software upgrade has been completed and the conversion seems to have been successful. The new program should streamline administrative processes and create easier to read reports. Also noted was the mailboxes have been moved back to the original positions.
