A discretionary use application was received by the Village Office after 205 Maclachlan was found to be in contravention of Bylaw #3-2014 s.3.5, and the Planning and Developing Act, s.62(1), by our Bylaw Enforcement Officer. Council was presented with nine letters from ratepayers regarding the application for discretionary use of 205 Maclachlan, as a U-Haul Rental Depot. Eight letters were opposed to the use in that location, and one letter was neutral.

Councillors validated ratepayer concerns with the esthetics of the lakefront in the Resort Village, as well as the lack of parking. Mayor Petersen acknowledged that Council had received an additional letter from Marcie Seymour, but Council was unable to use the submission because it was written out of a breech of confidentiality, the Municipalities Act s.144(2), and Bylaw 8-2016, s.(e).
