Winnipeg Street for \$4000 to \$5000. Also a rough quote of around \$76,000 was given regarding installation of sewer and water on Hayter Street.

Acting Administrator, Beverley Laird submitted a written report on various tasks that were being completed. The advertisement for the newly created position of Assistant Foreman has had an excellent response with approximately12 resumes to date. A grant for student summer employees has been filled out and sent in. Four positions (3 outside and 1 office) have been applied for. Preparations are being made for the spring newsletter to be distributed in the March utility billings. Contact has been made with a potential grant write. Mr. Engele expressed interest in this type of piece work and council will put together a proposal. There will be an Assessment Appeals Committee hearing on Thursday, April 7, 2011 involving the Manitou Springs Hotel Inc.
