Woiden Construction is stock piling some rip rap for us in case of emergencies and the grader will need to have the clutch fixed.	
	Acting Administrator Beverley Laird reported on three employment grants we have been approved for. Two for students, and one for a designated labourer for CiB. The process for applying for a weight restriction on the highway running through the beach was outlined and the plan for publishing a monthly newsletter rather than only 2 or 3 a year.
