Mr. Upshall & Council discussed a park fence on the West boundary of Uhmann Park, as well as a transplanting of saskatoon berry trees planted to create a false property line. Council noted they would discuss transplanting the trees with the Parks Committee, when the walking path is installed. A chain link fence was discussed as a transparent, boundary line for the park.

Delegation Gary Jay and Dawn MacLachlan arrived at 2:23 pm.

Gary Jay announced he would be speaking for the delegation on behalf of CIB. Mr. Jay requested clarification of responsibility for watering plants/trees that were planted as a plan made by CIB. Council asked Mr. Jay how their contract watering went this past season, and Mr. Jay reiterated how successful the venture was. There was consideration that CIB take responsibility for the follow through in their future plans. CIB & the RVMB Parks committee will be putting together a plan to bring forward to Council.
