AMENDMENT TO ZONING BYLAW 3/2014
BYLAW 3/2026

A Bylaw to amend Bylaw No. 03/2014, known as the Zoning Bylaw

The Council of the Resort Village of Manitou Beach, in the Province of Saskatchewan,
enacts to amend the Zoning Bylaw as follows:

1. Section 4.5 ACCESSORY USES, Subsection 4.5.9.1 to delete 93 m² and replace with 111 m².
2. This Bylaw shall come into force and take effect upon adoption by Council.

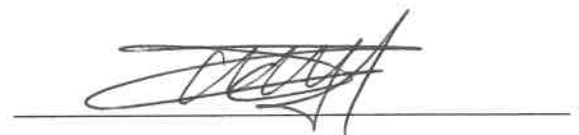
