EXTENSION OF TIME – FINANCIAL STATEMENT

Resort Village of Manitou Beach

BYLAW NO 4/2026

A BYLAW TO EXTEND THE TIME REQUIRED FOR THE COMPLETION OF THE 2025 FINANCIAL STATEMENT

The Council of the Resort Village of Manitou Beach in the Province of Saskatchewan enacts as follows:

For the 2025 financial year, the time required for completion of certain financial and audit procedures for the Resort Village of Manitou Beach be extended as follows:

- (a) The time required pursuant to subsection 185(1) of *The Municipalities Act* to complete the annual audit of the municipality's books and records of the annual financial statement be and is extended to August 31, 2026.
- (b) The time required pursuant to subsection 186(1) of *The Municipalities Act* for the submission of a copy of the financial statement and the auditor's report be and is extended to September 29, 2026.
- (c) The time required pursuant to subsection 185(3) of *The Municipalities Act* to publicize the financial statement or synopsis and auditor's report be and is extended to October 31, 2026.

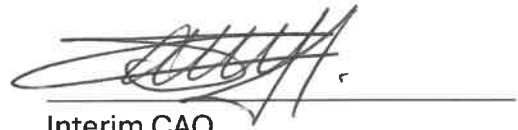
